Unlike most publishing houses, Raconteur Media gives its clients content licensing rights under certain conditions. We encourage you to share our content for your business needs and purposes, but require that you do so only if you read and agree to the below details.

Raconteur special reports and special interest content, as independent material, can be a great way to educate your key stakeholders and to strengthen your collateral for sales, business development, marketing and PR. Under these content licensing guidelines, Raconteur Media Limited (the "Licensor") a grants certain usage rights of the Licensor's content and material (and the underlying intellectual property rights) to the client (the "Licensee") as set out below.

The following defined terms are used in these guidelines:

'Content' refers material and content in two distinct and separate pieces of Licensor's intellectual property – Reports and Sponsored Content

'Report' refers to the entire Special Report published by the Licensor in The Times or The Sunday Times;

'Sponsored Content' refers to the individual advertorial the Licensee has paid for in the Report.

The terms of the content licensing guidelines are as follow:

- 1. The Licensor retains all rights, title and interest in and to all copyrights and other intellectual property in the Content.
- 2. The Licensee may not sell or sublicense any Content originally published by the Licensor.
- 3. Only the Licensee may use the Content solely for its own use.
- 4. The Licensee has a non-exclusive, worldwide license to use, reproduce, distribute and/or display the Content in hard copy format.
- 5. The Licensee has an exclusive, worldwide license to use, reproduce, distribute, display and transmit the Sponsored Content in electronic format, and to permit its own users to download the Sponsored Content. Licensees' rights to modify the Sponsored Content are limited to the right to modify the format in order to fit the look and feel of the site.
- 6. If sharing Sponsored Content online, the Licensee must link the content back to www.raconteur.net as the Content source
- 7. The Licensee has a non-exclusive, worldwide license to use, reproduce, distribute, display and transmit the Report in PDF format, and to permit users to download the Report. Licensees have no rights to modify the Report.
- 8. The Licensee may not change the title of the Content in any way.
- 9. The Licensee has a non-exclusive, worldwide license to use, reproduce and display the Licensor's logo and corporate identification in connection with Content in print and online.
- The use of any Content originally published by the Licensor, whether in part, in full or in modified format, must be accredited as below: As originally seen in '[REPORT TITLE]' published by Raconteur Media on [PUBLICATION DATE] in

[THETIMES/THE SUNDAYTIMES].
